- 9. Identify and describe the function for skin care essentials, infection control and safety, and the client consultation.
- 10. Explain techniques for each type of hair removal and how procedures differ for face and body.
- 11. Differentiate between temporary and permanent hair removal services
- 12. Identify the considerations for waxing.
- 13. Explain the difference between the various advanced massage techniques and their specific contraindications.
- 14. Describe the different types of medical procedures performed by physicians that are related to the esthetics profession.
- 15. Identify various ways of gaining additional and advanced training to become qualified to work in a medical setting.
- 16. Explain the various esthetic procedures applied in a medical practice.
