# **SYLLABUS**

## CATALOG DESCRIPTION

Serves as the field internship component of the paramedic curriculum. Provides an opportunity for Paramedic students to apply their new knowledge in real patient care situations. Course is a minimum of 500 hours but may require additional hours to complete required skills. Special prerequisite: Acceptance into the paramedic program.

## **Course Learning Outcomes**

Course Specific Objectives:

At the completion of this course, the Paramedic student will be able to:

- 1. Explain the need for the incident management system (IMS)/ICS in managing emergency medical services incidents.
- 2. Describe essential elements of scene size-up when arriving at a potential multiple casualty incident (MCI).
- 3. Describe the role of the paramedics and EMS systems in planning for MCIs and disasters.
- **4.** Define the following types of incidents and how they affect medical management:
  - (a) open or uncontained incident; (b) closed or contained incident.
- 5. Describe the functional components of the incident management system (IMS) in terms of the following:
  - (a) command; (b) finance; (c) logistics; (d) operations; (e) planning.
- 6. Differentiate between singular and unified command and state when each is most commonly applicable.
- **7.** Describe the role of command.
- **8.** Describe the need for transfer of command and procedures for transferring it.

## **Completion of the Field Internship Requires:**

- A minimum of 350 internship hours with an assigned preceptor.
  - Completion of a minimum of 50 ALS level calls as the lead medic.
    - An ALS level call should include at least one attempt at an invasive procedure;
    - Lead medic is defined as: being in charge of all aspects of patient care with little or no assistance from the preceptor;
    - The status of the call and whether or not the student performed as "lead" is solely the judgment of the preceptor, and the decision will be respected by the student, and;
    - o Successful completion of all components in the terminal evaluation.

#### GRADING SCHEMATIC FOR FIELD INTERNSHIP:

The student's overall grade in the field internship will be determined using the following criteria:

- o Performance of skills and critical thinking
- o Affective behavior/Professional performance
- Quality of narratives/DCHARTE's
  - o Spelling, grammar is a must! Spelling and grammatical errors will count against grade
- o Paperwork submitted and turned in on time
- o Preceptors' evaluations of student
- o Fulfillment of ≥50 ALS Lead Calls
- o Fulfillment of ≥350 field internship hours
