CATALOG DESCRIPTION

Veterinary Business Procedures 2 is an intermediate course designed to build on the knowledge and skills covered in VETT 112, with an emphasis on the human element of the business of veterinary practice.

Course Learning Outcomes

- b. Perform as a productive and contributing member of the veterinary team, including identifying problem areas and proposing effective solutions.
- c. Contribute to a positive work environment through an awareness of individual style and needs.
- 2. Communication Taking into account the patient, client, staff and circumstances, the veterinary technician will be able to effectively and accurately acquire and convey information utilizing an appropriate communication mode.
 - a. Demonstrate an understanding of interpersonal skills and team dynamics.
 - b. Develop and provide client education in a clear and accurate manner at a level the client understands (i.e. oral and written form, including educational handouts).*
 - c. Effectively and accurately acquire and convey information utilizing an appropriate communication mode.*
 - d. Apply crisis intervention/grief management skills with clients.*

3. Healthy work environment

- a. Understand and recognize the signs, causes, and coping strategies associated with stress and burnout in the field of veterinary medicine.
- b. Understand and recognize the signs, causes, and coping strategies associated with compassion fatigue in the field of veterinary medicine.

4. Human-Animal Bond

- a. Describe the knowledge gained from research related to the human—animal bond, both emotional and physical.
- b. Explain how societal norms and economic conditions affect the human interaction and treatment of animals.
- c. Articulate the difference between animal welfare and animal rights and the implications of both on the practice of veterinary medicine.
