Catalog description: A study of the fuel and emission control systems used on current model General Motors vehicles. Troubleshooting method for General Motors fuel, electrical, and electronic systems. Instruction will include diagnostic procedures on fuel injected engines, including direct injections. Engine conditions, and diagnosis and repair of engine sensors and system monitors. Students will learn to use an exhaust gas analyzer, oscilloscopes, and other special test equipment.

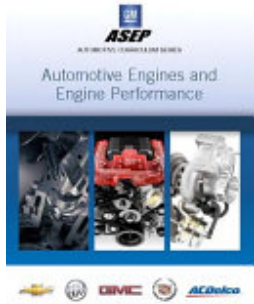

Course Level Objectives

1. Demonstrate safe techniques for servicing fuel systems.
2. Identify the six systems of a carburetor.
3. Test the fuel delivery system. (Mechanical and electrical)
4. Diagnose & replace fuel regulation components.
5. Diagnose and repair an exhaust gas recirculation system.
6. Diagnose and repair an evaporative emission system.
7. Diagnose and repair an inlet air management system.
8. Diagnose and repair an early fuel evaporation system.

9. Diagnose and repair an air injector system.
10. Test for water and alcohol in gasoline and perform a Reid Vapor pressure test.
11. Use exhaust gas analyzers to check emissions on a vehicle.

Course Time Commitment

The General Motors Web Based E-Learning modules will require students to dedicate time after class to complete them. You should plan on completing 4-5 E-Learning modules each week.

Daily reading assignments and study will require 1-2 hours of time out of class each day.

Canvas Participation and Expectations

Announcements, student labsheets, grades and supplemental reading/study material will be posted on Canvas. Students are expected to log into Canvas daily to check for new announcements and grade updates.

Participation and Attendance Policy

Because of the class emphases on hands-on lab activities, consistent attendance is required. Students that are not in class when attendance is taken will be counted absent. Personal errands should be scheduled for times that will not conflict with class schedule. Students will not be given make-up work.

Federal and State education guidelines has stated that students missing 10% or more of their classes should not be eligible for class credit. The SJC Automotive Department uses the attendance rubric below when calculating your attendance.

If you miss 10% of your classes you will receive an "X" grade. Refer to the following chart:

Understand that this is based on percentage of the total number of days available in the course based on the official SJC course calendar. For example:

If your course schedule shows that a course runs 20 days (4 weeks), 2 missed days would count as missing 10% of the available days and would result in an incomplete X grade.

So each day in a 20 day course counts as 5%. Each day in a 40 day course counts as 2.5%. Each day in an 80 day course counts as 1.25%, etc.

Also remember that late arrivals are counted absent.

Instructor normally responds to phone calls/texts and emails the same day.
