GENERAL OBJECTIVES:

General objectives of the course are:

- A. To introduce the student to the legal environment of business, including the legal process, constitutional law, criminal law, and tort law.
- B. To introduce the student to the nature and law of contracts, including formation of contracts, special aspects of contracts, discharge of contractual obligations, and remedies for non-performance of contractual duties.
- C. To introduce the student to the administrative law process, including antitrust, consumer and environmental law, rules, and regulations.

SPECIFIC OBJECTIVES/OUTCOMES:

At the conclusion of this course the student should be able to:

- A1. Name the basic documents used to initiate and respond to civil actions filed in a legal tribunal.
- A2. Explain the function of a trial court and an appellate court.
- A3. Explain the difference between a criminal case and a civil case in terms of purpose, relief, and impact upon business and society.
- A4. Discuss the basis of the power of government to regulation businesses under the United States Constitution.
- B1. Identify the basic elements of a contract.
- B2. Evaluate common commercial contracts to determine if any special considerations are necessary to make them enforceable.
- B3. List and explain three basic ways that contractual obligation can be discharged.
- B4. List three basic classifications of damages awarded by courts, identify the type most often used in breach of contract cases, and explain the purpose of an award of damages for breach of contract.

- C1. Explain how administrative agencies are created and outline the general steps in rulemaking.
- C2. Discuss the separation of powers issue in the establishment of administrative agencies.
- C3. Analyze how monopoly powers are established and controlled by government regulation.
- C4. Differentiate between per se and rule of reason evaluation of antitrust violations.
- C5. Describe methods used by the government to protect consumers.
- C6. Evaluate in general terms the effectiveness of consumer debtors protection laws.
- C7. List the four major areas regulated by environmental laws and be able to discuss in general terms how this impacts businesses.
