SYLLABUS

CATALOG DESCRIPTION

Treatment strategies for patients with complex diagnoses such as developmental disorders, CVA, TBI, SCI, AKA/BKA, and UMN/LMN lesions. Study of the nervous system and techniques related to the theories of neurological development. Study of abnormal gait, types of wheelchairs, and types of supportive devices.

 - 10e. Analyze gait patterns with a prosthetic device. (L,T,C)
 - 10f. Demonstrate competency in appropriate treatment techniques for mock patients with an amputation to meet requirements outlined in the skill check and lab exam. (L,T,C,I,A)
11. Review appropriate treatment programs for patients with an upper motor neuron (UMN) or lower motor neuron (LMN) lesion developed within the plan of care.

 - 11b. Describe the pathological conditions that normally occur for a given lesion. (L,T,C)
 - 11c. Demonstrate competency in appropriate treatment techniques for mock patients with a UMN/LMN lesion to meet requirements outlined in the skill check and lab exam. (L,T,C,I,A)
12. Explain outcome assessment related to course content.
 - 12a. Identify equipment and resources necessary for discharge. (L)
 - 12b. Finalize a functional home exercise program including ADLs. (L,T,C,I,A)
 - 12c. Provide input to the supervising physical therapist about outcomes. (L,T,C)
