# **SYLLABUS**

# CATALOG DESCRIPTION

This 7 week clinical externship provides students with the opportunity to apply clinical skills acquired in the academic setting directly to geriatric and neurologically involved patients in a rehabilitation setting. This externship may be completed in any geographical area provided that a legal contract is established between the clinical site and San Juan College.

Prerequisites: PTAP 210, PTAP 230, PTAP 250, PTAP 260

Semester Offered: Spring for on-campus; Fall for online program

# **Clinical Grading Criteria**

Students will be evaluated on each clinical rotation by the clinical instructor using the APTA Clinical Performance Instrument (CPI). The Academic Coordinator for Clinical Education (ACCE) assigns the course grade based on the CPI, Generic Abilities, and additional grading criteria. Per the CPI, the ACCE may also consider the:

- clinical setting
- experience with patients in that setting
- relative weighting or importance of each performance criterion
- expectations for the clinical experience
- expectations of the clinical site
- progression of performance from mid-experience to final evaluations
- level of experience within the didactic and clinical components
- whether or not "significant concerns" box or "with distinction" box were checked
- congruence between the CI's narrative mid-experience and final comments related to the five performance dimensions and the ratings provided
- additional assignments (eg, journal, in-service education provided)
- site visit information

### **Minimum Passing Criteria**

Students must meet the minimum passing criteria in order to pass the clinical rotation. The minimum passing criteria for each rotation is as follows:

### Clinical Rotation I

- Completes a minimum of 160 hours of clinical education.
- Receives a minimum acceptable rating of Advanced Beginner for all 14 criteria applicable to an acute care setting on the CPI
- Receives a minimum acceptable rating by the ACCE of Beginning Level Behaviors on the Generic Abilities.

### **Clinical Rotation II**

- Completes a minimum of 280 hours of clinical education.
- Receives a minimum acceptable rating of *Intermediate* for all 14 criteria applicable to the setting on the CPI for this clinical rotation or on a previous clinical rotation.
- Receives a minimum acceptable rating by the ACCE of *Developing Level Behaviors* on the Generic Abilities.

# **Clinical Rotation III**

- Completes a minimum of 280 hours of clinical education.
- Receives a minimum acceptable rating of *Entry-Level* for all 14 criteria applicable to the setting on the CPI for this clinical rotation or on a previous clinical rotation.
- Receives a minimum acceptable rating by the ACCE of Entry Level Behaviors on the Generic Abilities.

# **Additional Grading Criteria**

The grade for the clinical rotation will also be based on the following:

- Sends the packet to the clinical site by the due date.
- Completes and signs off on the Midterm Self-Evaluation in CPI Web by the due date.
- Completes and signs off on the Final Self-Evaluation in CPI Web by the due date.
- Submits the APTA PTA Student Evaluation: Clinical Experience and Clinical Instruction to the ACCE by the due
  date.
- Submits the SJC Anonymous Student Evaluation of Clinical Rotation to the ACCE by the due date. Presents an inservice to the staff during at least one of the three clinical rotations. Students may be required to do more than one presentation upon request by the facility. The topic should be agreed upon by the student and the CI.

# **Attendance**

Students are required to follow the CI's work schedule. During the clinical rotation, students are required to be at the facility full-time for a minimum of 40 hrs/wk. The student may be required to work more than 40 hrs/wk at the discretion of the CI. If the clinical instructor does not work 40 hrs/wk, then the student may work with another PT, PTA, or appropriate health care professional to meet the full-time requirement at the discretion of the CI and ACCE. The student may also complete special projects to meet the full-time requirement at the discretion of the CI and ACCE.

#### **Absenteeism**

If you are absent from the clinic for any reason during the CI's work schedule, you are required to discuss the reason with your CI and ACCE prior to your absence except for emergencies. In the case of emergencies, the student should notify the CI and ACCE as soon as possible. Students are required to make-up any time due to absences. San Juan College closure due to holidays or inclement weather does not affect PTA students on clinical rotations.

# Remediation

If the student does not meet the minimum passing criteria for a clinical rotation, then remediation will be necessary. The ACCE will develop a student learning plan to facilitate the student's progress toward a passing level. This remediation may delay progression through the program and/or graduation.

If a student is required to repeat a clinical rotation, the highest possible grade will be a C grade. The clinical rotation must be repeated in the same type of facility. Placement is dependent upon the availability of another facility of the same type. An additional placement is not guaranteed.

Of the three clinical rotations, only one rotation may be repeated. If a student fails a second clinical rotation, the student will be dismissed from the program.

# **Dismissal**

The Clinical Coordinator for Clinical Education (CCCE), clinical instructor (CI), and/or ACCE has the right to dismiss a student from a clinical rotation. This dismissal may result in a failing grade for the clinical rotation. Dismissal from a clinical rotation may result in dismissal from the program.

Students who do not adhere to the requirements outlined in the SJC PTA Program Student Handbook may not pass the clinical rotation and may subsequently be dismissed from the program. Options to return to the program will be at the discretion of the Program Director.

# **Assessment Techniques Used But Not Limited To:**

- 1. CPI
- 2. Midterm and Final Report for each clinical externship.
- 3. Evaluative communication between the ACCE and CI during each clinical externship via telephone, email, and/or site visit.

# **Accommodations Statement**
